



MEMORANDUM OF UNDERSTANDING  
BETWEEN  
RAJAMANGALA UNIVERSITY OF TECHNOLOGY RATTANAKOSIN  
AND  
FURAMA GROUP HOTEL

This memorandum of understanding is made between Rajamangala University of Technology Rattanakosin by Asst. Prof. Siwa Wasuntarapiwat, President located at 96 Mu3, Phutthamonthon Sai 5 Road, Salaya Subdistrict, Phutthamonthon District Nakhon Pathom Province, 73170 and Furama Group Hotel by Mr. Chanawit Islam, Authorized Director/Authorized Personnel, located at 533 Silom Road, Silom Subdistrict, Bang Rak District, Bangkok Province, 10500.

Rajamangala University of Technology Rattanakosin and Furama Silom Hotel agree to cooperate in the provision of integrated education between school learning and full-time work in professional establishments. Students will gain work experiences from real practicing by applying ideas and theories together with fulfilling the knowledge gained from classroom teaching. This will regard as the potential development of professional skills for students and will be benefit for the graduate user organization as well as the exchange of knowledge and good coordination between universities, public and private sectors corresponding to the objectives and the philosophy of the university and cooperative education.

Both parties agreed to pursue the following cooperation:

1. Obligations of Rajamangala University of Technology Rattanakosin

- 1.1 To be responsible for students selection for working at the establishment;
- 1.2 To be responsible for being a coordinator in cooperative education with the establishment;

1.3 To be responsible for sending cooperative education faculty members to examine students' progress at least 2 times

2. Obligations of the establishment

2.1 To be responsible for accepting students for working at least 4 months;

2.2 To be responsible for defining a workload or project topics that match with the students' proficiency and work experience;

2.3 To be responsible for giving knowledge and taking care of students while working at the establishment;

2.4 To be responsible for providing compensation for students not less on 10,000 Baht per month;

2.5 To be responsible for providing welfare in case of domestic working, such as meals, uniforms, and others (if any);

2.6 To be responsible for providing welfare in case of overseas working, such as accommodation fee, round-trip airfare, transportation fee from the airport to the establishment, meals, uniforms, and others (if any).

3. If one party wishes to terminate this MOU before the expiration date, that one party should send written notice to another one party.

4. This MOU shall become effective when the representatives of both parties sign below, and shall remain effective until 30 September 2024 (4 years). This MOU shall be renewed for a further period by written a new MOU.

This MOU is signed in duplicate. Both documents shall be deemed as originals with each party keeping one. Both parties have read and understood the purpose thoroughly with the willing in operation and support the cooperative education in order to develop Thai graduates and strengthen to compete with international. Both parties have set their hands in the presence of witnesses in evidence hereof.
